Safe in the Deep End: Confined Space Entry and Gas Monitoring in Wastewater Operations

Janette Kessler, ACUA

This session covers essential safety rules for entering dangerous underground areas at wastewater plants. Attendees will learn how to test the air for toxic and explosive gases, use portable monitors correctly, and follow OSHA guidelines to prevent tragic accidents in low-oxygen environments. Historically, PFAS ("forever chemicals") were widely used in industrial processes and consumer products throughout New Jersey before their persistence and potential health risks were fully understood, resulting in contamination of some groundwater and drinking water supplies. Today, New Jersey is a national leader in PFAS regulation, with enforceable drinking water standards, expanded monitoring requirements, treatment upgrades, and ongoing remediation efforts to reduce public exposure and protect water quality.

Presentation will explain process for applying for congressional funding which typically begins with identifying a federal program or appropriations account that aligns with the proposed project. Applicants submit a detailed request to the appropriate congressional office, including a project description, budget, justification, and evidence of community benefit, after which the Member of Congress evaluates the request for potential inclusion in the annual appropriations process. For projects seeking Community Project Funding (House) or Congressionally Directed Spending (Senate), applicants must also meet chamber-specific eligibility, transparency, and disclosure requirements.
