State & Local Recovery Funds to Include \$\$ for Water and Sewer Infrastructure

On May 10, the U.S. Treasury released a fact sheet regarding the Coronavirus State and Local Fiscal Recovery Funds, which provides **\$350 billion in emergency funding** for eligible state, local, territorial, and Tribal governments.

The fact sheet says, “these funds also deliver resources that recipients can invest in building, maintaining, or upgrading their water, sewer, and broadband infrastructure.” It states that “recipients may use this funding to **invest in an array of drinking water infrastructure projects** such as building or upgrading facilities and transmission, distribution, and storage systems, including the replacement of lead service lines,” and that “recipients may also use this funding to invest in wastewater infrastructure projects, including constructing publicly-owned treatment infrastructure, managing and treating stormwater or subsurface drainage water, facilitating water reuse, and securing publicly-owned treatment works.”

Some of the money will go directly to municipalities. For example, Edison will receive \$15.6M, Trenton will receive \$73M and Toms River Township will receive \$15.4M. Money for smaller

municipalities will go through the State.

The Treasury Department also said it will aligns eligible sewer and water projects with eligibility for SRF money. It is not clear yet how authorities would access funding, but Treasury said more information is coming.
